Medicaid staff return to the office on Monday, March 17<sup>th</sup>, 2025

Several exempt, bargaining units have received notices to report back to the office on April 14<sup>th</sup>, 2025

ODJFS did not participate in the 40 mile

Rumors addressed:

There are some locations being looked at for JFS employees to return to the office Metro, NE, NW, SE, SW in Columbus

Employees will not be going back to 4020

Kroger on Morse Rd. not an option as this building was purchased by Franklin County Board of Elections

No space at Department of Taxation

JCP Outlet unfounded

Fisher Rd on the West Side-DAS taking that space

Do not believe JFS will be downtown

Statewide grievance filed

Medicaid did not file a grievance

Contract language does not give the employees the right to telework, agency only obligated to give notice to employees. The only recourse is to file ADA accommodations. Agency determines what reasonable accommodation. It must be for "You" not a family member. ADA accommodation would be if your doctor identified that you have a disability that will allow you to do your job at home

Be where your supposed to be

No language in the contract that talks about you staying at home

No discussions about JFS employees working 4, 10-hour days

JFS may be required to submit telework logs

Make sure you pay attention to the gubernatorial election in November. Pick the person that is going to make your life easier. Pick a boss that the union can work with

Pay union dues

Marijuana is legal in the state of Ohio, however, you cannot be high at work. Do not give them reasonable cause to test you

#### Discussion

8 people voted Yes




