Event started for me on Wednesday with early registration and credentials from 5pm – 9pm, you could then participate in trainings (Financial Leadership or New Delegate Workshop). If you were on one of the committee's you might have needed to attend a meeting (Credentials, Rules, or Sgt-at-Arms Committee).

Thursday started with registration opportunity if needed from 8am – 9am with general session starting at 10am. You could also use the morning before general session to attend workshops if not attended on Wednesday. There was also another workshop added on Thursday, Future of Work Expo. In this workshop you could gain information on AI and other new technologies that may come into our workplace and how they can help us instead of feeling like they may replace us. They also have some virtual booths set up.

General session started with the Honor Guard and pledge of allegiance followed by members of the credentials committee establishing if there was a quorum. This was followed by members of the rules committee who made motion to accept and adopt the rules and agenda for the convention. The convention continued with Justin Bibb, Mayor of Cleveland who welcomed us to the city, he was followed by Chris Mabe who spoke about the importance of all agencies and how most politicians do not know how departments work. He also talked about the "People" program and its importance. Theme for the day "Each One Teach One". This was followed by several other speakers to include Kathy Stewart (OCSEA Sec/Treasurer), Rocky Jolly (Vice President of OCSEA) and Sherrod Brown (US Senator).

We attended a luncheon provided by WAC/CMAC who also had a speaker during the meal. This speaker was Kathleen Clyde (Chair of Ohio Democratic Party) who spoke about the importance of voting.

The afternoon continued with presentations about New Member Benefits by Pearl Insurance and presentation on AI and its use in the workplace. Later in the evening there were bus trips to Cleveland Aquarium.

Friday started about 9:35am with Pledge of Allegiance followed by Rocky Jolly providing update with People's numbers from each district. You could also attend New Employee Workshop in the morning prior to the start of the session.

This was followed by Credentials committee update on voting numbers at the convention. This was followed by speaker Dr. Amy Acton (Former Director of the Ohio Dept. of Health) who also is candidate for upcoming Governor race who spoke about youth, supporting each other, and why she is running for Governor.

Later there was a reading and adopting of all proposed resolutions.....all passed.

Later there was a tribute to Ron Alexander (former president of OCSEA) he was presented with special award for his years of dedication and the new naming of the OCSEA building to be renamed the Ron Alexander Building. You could also attend New Employee Workshop in the morning prior to the start of the session.

The evening started with a Delegate Reception where we had the opportunity to fellowship and meet other union members from various areas and agencies.

Saturday started with the Honor Guard followed by another "People" organization update. This was followed by credentials update, then a presentation of the leadership award (Jean Fightmaster Award) which was given to Joe Wing. August 28, 2025

Justin Bibb is the youngest African American Mayor I've had the option to meet and hear speak. He is 38 years old and was elected as the Democratic Mayor in 2022. It was very impressive to have him do the Welcome Address to start our convention.

President Mabe gave his State of the Union speech. I must say he knows how to get us fired up! One thing that our entire group loved when he referred to our grown still living at home children as CHIL-DULTS. We as Union members are facing the biggest challenge of our lives and have this current administration. The attack on unions and our rights is a fight we must continue to fight. They have already stripped Federal Employees of their union and they are coming for State unions as well.

Kathy Gersper, Secretary - Treasurer gave a financial report and provided

Rocky Jolly Vice President introduced the PEOPLE Challenge. Trying to get Chapters to increase their contributions up to 100%. The chapter that wins the competition will receive and \$1,000 rebate.

WAC Luncheon - FOOD WAS HORRIBLE! Very disappointed that our Chapter paid for the lunch because it was not worth it at all. Kathleen Clyde, Ohio Democratic Party gave a speech on what we are up against and how to fight back.

Sherrod Brown - I wish he was running for Governor! He is one politician that I trust and believe in. He is true to his word and stands in the fight with us. It was funny how he kept referring to our members who did not vote for him and how he is still fighting. He also let it be known that the Bernie Moreno is not doing what he promised. He got the votes and now he is putting things in place that is harming everyone. August 29, 2025

The Republican candidate has already made the announcement, has commercials on TV and on social media. Constitution Amendments - I was very disappointed in the leadership of OCSEA and how they prevented the submitted amendments to the constitution but we're not allowed to be heard. The amendments were

directed toward the officers of OCSEA and the amount that they receive and the privileges that they have taken upon themselves that is not in their position descriptions. I believe all of them should've been heard by the body so we could've voted on them and made some changes in my opinion. It was all rigged and that's why they had the ending session starting out, giving out gifts and put all the other business aside. As soon as the gifts were distributed, one person stood up to adjourn the convention, and none of the amendments got to be heard. I wish everyone could have read the amendments and you will understand why I feel the way I do. I'm so glad we had new delegates to attend so they can see the process and experience the convention in its entirety.

President Lee Saunders - as usual, he gave the best speech in the house. OCSEA 36th Biennial Convention Recap

August 27–29, 2025

The OCSEA 36th Biennial Convention kicked off on August 27, 2025, with Financial Leadership training led by Kathy Gersper. She thoroughly explained the rebate process, highlighting how the OCSEA Constitution impacts our rebates and ensures our continued financial compliance with OCSEA and AFSCME standards. New delegate orientation was conducted by Jeff Freeman, Angela Harrington, and Tim McAllister, where attendees learned about the structure of the convention and parliamentary procedures. Each delegate received a copy of Robert's Rules of Order and practical examples of what to expect when speaking at the microphone.

On August 28, 2025, we were honored to hear Justin Bibb, the youngest African American Mayor I've had the opportunity to meet and listen to. At 38 years old, Mayor Bibb was elected as Cleveland's Democratic Mayor in 2022, and his Welcome Address was a motivating start to our convention. President Mabe then delivered an inspiring State of the Union speech, energizing the crowd—especially when he referred to our grown children still living at home as “CHI-DULTS.” As union members, we are facing unprecedented challenges under the current administration, and the attacks on unions and our rights remind us to stay vigilant and keep fighting. Federal employees have already lost their union representation, and now state unions are under threat.

Kathy Gersper, Secretary-Treasurer, presented a financial report and shared updates on our fiscal status. Vice President Rocky Jolly introduced the PEOPLE Challenge, urging chapters to increase their contributions to 100%. The winning chapter will receive a \$1,000 rebate as incentive. Unfortunately, the WAC Luncheon was disappointing—the food did not meet

expectations, especially considering our chapter paid for it. Kathleen Clyde from the Ohio Democratic Party delivered a speech addressing the challenges we face and strategies to fight back.

Senator Sherrod Brown also spoke, and I sincerely wish he was running for Governor. He's a politician I trust and believe in—always true to his word and standing with us in the fight. It was amusing how he referenced members who hadn't voted for him, emphasizing his ongoing commitment to us. He also pointed out that Bernie Moreno has failed to deliver on his promises, aligning with the current administration's agenda to provide tax breaks for the wealthy while harming middle-class workers.

August 29, 2025, featured Amy Acton, a remarkable speaker, though I have reservations about her candidacy for Governor of Ohio. As I mentioned in a previous conference report, her campaign has lacked visibility—no advertisements or commercials—while the Republican candidate is already active on TV and social media. Without increased awareness and engagement, we risk falling behind in the upcoming election.

The handling of Constitution Amendments was disappointing. OCSEA leadership prevented submitted amendments from being heard, especially those targeting officer compensation and privileges beyond their position descriptions. I believe these issues deserved discussion and a vote from the body, but the process felt orchestrated to avoid important business. After distributing gifts, the session quickly adjourned without addressing any amendments. I'm glad new delegates could witness the process and experience the convention firsthand.

President Lee Saunders delivered his usual powerful address, passionately speaking about the challenges facing the United States and the threats to our rights. He emphasized the urgent need for unity and action against the current administration's harmful policies. I refuse to bow to these plans and will continue to stand for what's right, fostering respectful disagreement while maintaining relationships. Enough is enough—it's critical that we stop enabling harmful behavior, especially in front of our children. President Saunders reignited my commitment to vote against those who threaten our values and to register others to vote. I hope everyone recognizes the importance of this moment and makes their voice heard at the polls.

Overall, I had an incredible experience at the convention and enjoyed sharing it with the six new delegates who attended. With election season approaching and OCSEA officer positions opening soon, it's time to get organized and ready for the challenges ahead.

He believes in affordable housing and his Side Promise Program is currently working to expand affordable housing and meanwhile his RISE initiative has currently reduced homicides by 36% at the same time, achieved record police recruitment.

THE MEMBER-ONLY BENEFIT INSURANCE.

New member only benefit was announced at the convention. Thanks to our Union who will now provide No Cost workplace insurance of \$10,000.00 to members of the union. The effective date for this policy is Wednesday October 1, 2025. This benefit automatically applies to all dues-paying OCSEA members.

OCSEA partners with Pearl Insurance to offer this program. the Insurance covers death and dismemberment while on the job and hostage situations. The insurance coverage is provided to members only for free.

The "BIG BEAUTIFUL BILL"

That turned ugly will undoubtedly harm many working people and services in the country. This is because the new law makes the biggest cuts in services that people needs for their day to day living. There is already higher inflation in the country and the law is making prices of everything go higher and higher. For example the cost of eggs, energy, healthcare are going up. And workers are losing their jobs because the funding that supports our work are being cut.

This new law, will force states including Ohio to cut a lot of their regular programs because the Funds are no longer available to them either from the Federal Government or at the state level. Some States are now cut between raising new taxes or cutting programs and worker.

Now if Congress do not act by extending the tax credits and restore funding to states, Millions of families will not only have insurance coverage, but also their health insurance premiums will go up drastically. And not only that, a lot of jobs will be lost including Union member jobs.
